CFC REPORT NO. 129/04: ALLEGED GOS 2ND ATTACK ON THE VILLAGE OF LABADO ON 17 DEC 04

Reference:

- A. SLA Complaint dated 17 Dec 04.

INTRODUCTION

- SLA filed a complaint on the 17 Dec 04, alleging that GoS and Janjaweed/Armed Militia attacked the village of Labado on 17 Dec 04.
- Team D was tasked to investigate the allegation.

ASSESSMENT

3. Team D established that GoS forces, supported by Janjaweed/Armed Militia, attacked the village of Labado on the 17 Dec 04 at 0730 hrs, under the pretext of clearing the Nyala-Khartoum route and pushing out SLA/JEM forces from Labado and Muhajeria.

1 AU RESTRICTED

- During the attack five civilians were killed about 5km from Labado and parts of the village were burned down.
- 5. When the Military Observer Team wanted to enter the village of Labado on the 19 Dec 04, the GoS forces commander told them he could not guarantee their safety as there were still some rebel forces in the village. The GoS commander lied to the Military Observer Team about the Janjaweed/ Armed Militia on the northern area of their defensive position, by saying they were IDPs.
- 6. One of the Janjaweed/Armed Militias, who were in the northern part of the GoS defensive area, accused the AU of bias towards the rebel movements, allowing the rebel movements to kill and loot with impunity, as well as having rebel movement representatives in the teams that spy on them.
- 7. SLA/JEM abducted 3 civilian truck drivers, seized 4 trucks from a drilling team working at an NGO Water and Sanitation Project, as well as some goods from a convoy of truck drivers. The truck drivers and the Supervisor of the Water and Sanitation Project drilling team had been warned by the rebels that the road was not safe.

CONCLUSION

- 8. GoS violated Art 2(2) and (6) of the N'djamena Agreement, Art 1(1) of the Abuja Security Protocol, and Art 2 of the Abuja Humanitarian Protocol, by attacking the village of Labado on the 17 Dec 04.
- 9. GoS violated Art 2 of the Abuja Security Protocol by colluding with the

Janjaweed/ Armed Militia they undertook to disarm/neutralize.

 SLA/JEM violated Art 2(6) of the N'djamena Agreement by seizing civilian properties from the truck drivers and the Water and Sanitation Project drillers.

RECOMMENDATIONS

- 11. It is recommended that:
 - a. JC should pressurize the GoS to stop its operations of clearing the roads. SLA and JEM should stop interception of the roads.
 - b. GoS should stop colluding with the Janjaweed/Armed Militia, and comply with Art 2 of the Abuja Security Protocol.


INVESTIGATION REPORT ON THE ATTACK ON LABADO VILLAGE ON 17 DECEMBER 2004 BY GOS AND JANJAWEED MILITIA

INTRODUCTION


 Sector 2 Headquarters received a verbal complaint from the SLA/JEM that the GOS, backed by the Janjaweed Militia, attacked LABADO on 17 DECEMBER 2004. HENCE, Team D was tasked to conduct and investigate the alleged attack by the GOS.

INVESTIGATION


2. The Team conducted a patrol to LABADO by road. On the way to LABADO the Team stopped at the original position of GOS military forces which was about 8 Km before LABADO, but did not find any forces. It only found 2 destroyed trucks, containing ammunition inside and some beside them. The Team also found different kinds of ammunition in the field, and after 2 km from this position it found 5 corpses at different places suspected to be civilian. It was later discovered that the GOS forces had advanced further into LABADO.



Two destroyed trucks inside the previous GOS defensive area About 8 km from LABADO (on 19 December 2004)




Corpses about 5 km before LABADO (on 19 December 2004)

- Interview with Brigadier General AHMED ALHAJAR MOHAMED Commander of the GOS forces that deployed at LABADO on 19 December 2004 at 1145 hours.
 He stated the following:
 - a. On 16 December 2004 at 2400 hours, he got instructions from his Commander to finish his mission and return to NYALA at the morning of 17 December 2004. At 0730 hours on 17 December 2004 during his preparations for withdrawal, the SLA / JEM forces suddenly attacked his forces from different directions and, he had to defend himself using all available firepower at his disposal. His forces succeeded in destroying the rebel forces, and then he followed them towards LABADO.
 - b. The rebel forces, as they were escaping from LABADO, set parts of the village ablaze as tactical defense. When he reached the village, he did not find any civilian, but found some drivers and their mates with 26 trucks coming from different places passing through the village. The rebels stopped them and told them that the road was not safe. The rebels then took some goods and spare parts from them.

4. The Team observed some of the armed Arab nomads (Janjaweed Militia) on their horses and camels (numbering about 500), occupying the northern defensive area of the GOS forces. The Team asked the GOS Commander about these forces. He told the team that they were IDPs escaping to his place for protection. They had weapons to defend themselves. The Team noticed they were not IDPs as claimed by the GOS commander but Janjaweed Militia probably from the MISIRIYAH tribe.

The Team asked the drivers about the situation and was informed that the rebels stopped them and said the road was not safe, but that was after some goods and spare parts were taken from their trucks.

- 6. <u>Interview with Mr. AHMAD ALI AHMAD truck driver at LABADO</u>. He stated that the following items were taken from them:
 - A water tank with a capacity of 15 barrels.
 - b. A barrel of Gasoline.
 - c. Ten Gallons of engine oil.
 - d. A lorry cover cloth.
- Mr. OMER ALGAMRY AZZAT truck driver at LABADO stated that, the rebel forces took a diesel tank and a water tank from him.
- 8. Interview with BASONUGO HUSSEIN drilling supervisor at a Water& Sanitation NGO project on 19 December 2004. He stated that:
 - a. He moved from KHARTOUM on 7 December 2004 with one Land Cruiser and 3 Bedford trucks, and arrived at LABADO on 10 December 2004 at 1400 hours. The rebels stopped his convoy and asked for his identification and license, then they told him that the road was not safe and he could not move, they went to him on Sunday 12 December 2004 and told him that, they had a mission and needed his vehicle. They took the vehicle and changed its colour to a dark one.
 - b. On Thursday 16 December 2004 morning, he heard firing and saw burning at LABADO village. One of the rebels went to him and asked about the 3 drivers with him. The rebels hit them and took away the 3 Bedford trucks, all their money and the 3 drivers, and he had not seen them since their, the drivers' names were, SAID SAAD MOHAMED, HAMZAH HAROON and AMIN GASTIIN, the 3 drivers mates with the GOS now in LABADO village, their names were MOHAMED ADM, ABD ALAZIZ ADM and MORIS SATIMON.
- 9. The Team moved to the northern part of the GOS defensive area to confirm the investigation.
 - a. While moving one of the Janjaweed leaders stopped the team and began to shout, asking why we came to this area. He stated that.
 - The AU helped the rebels at all times with their problems. When they (Janjaweed)
 came to AU and asked for help, the AU never helped them to solve their problems.
 - (2) The AU allowed the rebels to do what they wanted, killed and looted. He said he was traumatised because he had lost 200 men.
 - (3) The AU had in its team some of the representatives of SLA/ JEM and all of them came here to gather information to send to their leaders. Which they wanted to use to attack them, and he as a leader of these Arabs, he didn't need any help from AU and the team must go away from that place.

10. The Team asked the GOS Commander to assist the team to enter the village, but he said it was not saving since some of the rebel forces were still hiding in the village. He stated that, he could not guarantee the safety of the team in the village.

ASSESSMENT

- 11. The Team in its investigation comes up with the following assessments:
 - a. The Team confirmed that, the GOS with the support of Janjaweed Militia launched the attack on the SLA/JEM stronghold of LABADO on 17 December 2004 at 0730 hour.
 - b. That, the attack was part of the GOS operations to clear the route from NYALA to KHARTOUM and push out the SLA /JEM forces from their strongholds in LABADO and MUHAJIRIYA.
 - c. Five persons believed to be civilians were killed about 5 kilometers from LABADO during the attack.

CONCLUSION

12. The Team concludes that on 17 December 2004 at about 0730 hours, the GOS forces supported by the Janjaweed Militia lunched a coordinated attack on the SLA/JEM stronghold of LABADO. During the attack 5 civilians were killed about 5 km from LABADO. The Team could not carryout comprehensive investigation as it was prevented from interring LABADO. The GOS had violated article 2 of the 8 April 2004 NDJAMENA ceasefire Agreement and the additional protocols.

RECOMMENDATION

- 13. It is recommended that:
 - a. The Government of Sudan should disarm the Janjaweed militia, respect the Ceasefire Agreement so that peace could prevail in the DARFUR region.
 - b. The Government of Sudan should stop further deployment of its forces into the SLA\ JEM areas.


