**CFC CEASEFIRE VIOLATION REPORT NO. 133/04: AMBUSH OF GOS CONVOY 10KM AFTER KAURA VILLAGE ON 20 DEC 04**

**INTRODUCTION**

1. GoS lodged a complaint to the effect that their Logistical Convoy had been on the way from Kabkabiya to El Fashir had been ambushed around 10km from Kaura village.
2. Team H was tasked to conduct the investigation.

**ASSESSMENT**

3. The team established that 14 SLA fighters ambushed the GoS convoy about 12.5km before the Umm Checkpoint on the 20 Dec 04. Consequently, 1 SLA fighter was killed, and another one, who was wounded, captured.

**AU RESTRICTED**

4. On its way to El Fashir on the 04 Jan 05, the team saw SLA fighters in the same general area of the ambush, with a truck driver who informed the team that the SLA fighters had robbed him of 3000 SD.


**CONCLUSION**

5. SLA violated Art 2(2) of the N'djamena Agreement and Art 1(1) of the Abuja Security Protocol, by ambushing a GoS convoy 12.5km from the Umm Checkpoint on the 20 Dec 04.


**RECOMMENDATIONS**

6. It is recommended that:
- a. SLA should educate its soldiers on the N'djamena Agreement and Human Rights and International Humanitarian Law.
  - b. Parties should move their soldiers away from the main roads.
  - d. GoS should treat POWs in accordance with International Humanitarian Law.





Investigation report  
Ambush of GOS convoy  
Location: 10Km after Kaura village

INTRODUCTION

1. A complain was lodged at sector 4HQ by the 7 Brigade commander through GOS representative at the sector on Monday 20<sup>th</sup> Dec 04 of an allege ambush on a logistic convoy going to El Fashir from KABKABIYA around 10 km from Kaura village.
2. Team Hotel was tasked to investigate the complain of the alleged ambush in the area. The team departed Sec. HQ at 09:30hrs on Tuesday 21<sup>st</sup> Dec 04, first to Umm checkpoint (military camp) to talk to the commander in order to collect information about the incident. Umm military camp is 15 km beyond the ambush point. The team also went to investigate the captured SLA fighter in El Fshir on its second day of interview on Tuesday 04 Jan 05.

INVESTIGATION

1. The Team interviewed the following:
  - a. Lieutenant Mohamed Hessien (camp commander Umm camp).
  - b. Corporal Ali Hadine Mostafa (medical assistant).
  - c. Sergeant Abakar hammad fares.
  - d. Haroon Hessien Idris Abdallah (captured SLA fighter).
2. The team gathered that the convoy was ambushed 10Km after Kaura village and 15Km before Umm checkpoint by 14 SLA fighters.
3. During an exchange of fire, one Khaled Mohamed SLA fighter (later confirmed to be the leader of the group) was killed and another SLA fighter called Haroon Hessien Idris Abdallah was captured and taken to Umm checkpoint for First Aid treatment on three gun shot wounds sustained during the attack before being taken under custody in El Fashir.
4. Khaleds dead body was left unburied on the day of the ambush and GOS soldiers collected two weapons (AK47) after the incident belonging to the deceased and the captured.
5. At the ambush area the team saw a new grave believed to be where the remains of Khaled was buried perhaps some few hours before the arrival of investigation team on 21<sup>st</sup> Dec 04.
6. The team on its way to El Fashir on the 04 Jan 05 saw SLA fighters in the same general area of the ambush with a truck driver ,who informed us that 3000 SD was taken from him by SLA fighters.

### ASSESSMENT


1. There is frequent movement of SLA fighters on the road between Kabkabiya and El Fashir.
2. The team observed that an ambush did occur in the area as empty cases were littered around and a fresh grave was found in the area.
3. Considering the movement of SLA fighters in the area is considered as a violation of the ceasefire agreement.
4. Money is frequently extorted from drivers and passengers on this road.

### CONCLUSION

1. In conclusion, the team holds SLA responsible for the attack on the GOS logistic convoy on the said date. As information from both GOS and the captured SLA fighter indicates, the attack was a planned ambush by SLA.

### RECOMMENDATIONS

1. The SLA authorities should be urged to respect and honor the ceasefire agreement.
2. The SLA authorities should be advised to keep their fighters off this high way and desist from harassing civilians and extorting money from them.
3. All parties to the conflict should be reminded to be mindful of the International rules governing the treatment of prisoners of war.

- a. On Monday 20<sup>th</sup> Dec at 10:00hrs a logistic convoy was ambushed by about 17 SLA fighters whilst traveling from Kabkabiya to El Fashir.
- b. During the attack the GOS soldiers killed 2 SLA fighters and injured 1 who was later captured and taken to Umm checkpoint where he received First Aid treatment before taken to El Fashir by the same convoy
- c. According to him, the captured revealed that their camp is called Azaba sheltering 74 fighters, south of Korma village.

  - d. The captured was given First Aid treatment at Umm checkpoint before taken to El Fashir.

  - a. He said that he belongs to SLA fighters, and he was the bodyguard to khaled (the deceased).
  - b. On Sunday 19<sup>th</sup> Dec 04 whilst moving from their Azaba camp to the Mora Mountains across the Kabkabiya – El Fashir high way their commander Khaled told them to spend the night at the ambush point where they deployed in a linear ambush form.
  - c. On 20<sup>th</sup> Dec 04 around 10:00hrs a convoy of 9 GOS vehicles approached from Kabkabiya, and the GOS soldiers started firing at them killing their commander, injuring him whilst their colleagues ran away.
  - d. He was captured by GOS soldiers, and 2 weapons was collected by GOS soldiers
  - e. He confirmed that he received First Aid treatment in Umm checkpoint before being taken to El Fashir where he was starved for 2 days without food and water to take a bath and subjected to beatings everyday except 3 days before the team went to see him on Tuesday 04<sup>th</sup> Jan05, he further stated that he was taken to the hospital once in El Fashir.
